

SELA 2016, in Havana, Honors Professor Burt

LEADING LEGAL scholars from throughout Latin America, the Caribbean Basin, Spain, and the United States meet annually for the Seminario en Latinoamérica de Teoría Constitucional y Política (SELA), a three-day seminar exploring the foundational ideas of constitutional democracy. This year's meeting was in Havana, Cuba, in June, where Guido Calabresi Professor of Law Daniel Markovits 'oo (below) gave the Inaugural Robert A. Burt Keynote
